	Please note that this is a preliminary list of courses. The final offer will be communicated to the nominated students in our Study Guide.

	Please also note that these courses will be organized into course packages (i.e. formal packages of 22.5-30 credits which look like one single course) or study tracks (informal course tracks of 22.5-30 credits which are made up of separate courses). These packages and tracks are not recommendations, but formal pathways which the students will need to choose between. A student cannot mix and match pieces of a course package and different tracks but will need to stay within one package or track in accordance with the information provided in the Study Guide.
Language requirements	Certification of English proficiency is not required for exchange students from partner universities.
Minimum credits	Exchange students are required by Mid Sweden University to study 30 credits per semester which is considered full-time studies.
Notification of Selection Results	The Notification of Selection Results is the letter of admission which the student will get after their course choices and eligibility has been evaluated. It determines what courses the student has a right to study at MIUN. Eligibility to courses is evaluated equally between all students, exchange students included. This means that an agreement between us and a partner is not enough to enroll a student into a course. The student also has to meet the eligibility criteria.
Visa requirements for non- European exchange students	Migration Board visa application information & form etc.: www.migrationsverket.se/English/Private-individuals/Studying-in- Sweden/Universities-and-university-college.html Getting a residence permit takes time – it is crucial that the student submits their application on the same day as they receive their admission results.
Learning Agreement	A student's learning agreements can only include courses to which they have been admitted in the notification of selection results. If there is a discrepancy between the Learning Agreement and the notification of selection, the notification takes precedent.
Course Registration	Course registration opens 2-3 days before the course starts. Students register for their courses upon arrival.
Change of Courses	After the notification of selection results has been sent out, there is a very limited to no chance of changing courses. There is also no add/drop period once the semester starts at MIUN. Therefore, it is absolutely vital that the students get their application right in the formal application round.
Language courses (Swedish)	"Swedish Language for foreign students" 7.5 ECTS may be taken in addition to other courses. The course is free of charge.
Exam periods	Examinations take place at the end of each course/module and are therefore spread out throughout the term. There are no final exams at the end of the semester. Sometimes re-takes are offered in January (for the fall semester) and June or August (for the spring semester)
Disability services	The home institution is responsible for contacting the host university to arrange support prior to student arrival: miun.se/en/student/service-and-support/studeramed-funktionshinder/
Grade conversion	Mid Sweden University does not provide ECTS grades, nor do we translate our own grades or grading scales into ECTS or any other grades. Each partner institution is responsible for any translation of Swedish/MIUN grades into their country's/institution's specific grading system. MIUN cannot provide percentages or

	any other information regarding a student's performance other than what can be provided formally via our Ladok system.
Transcripts of record	Due to GDPR regulations, Mid Sweden University is unable to provide partner institutions with a student's transcript of records. We can only provide the student with said information via the Ladok system (not via the International Relations Office) and then it is up to the student to forward this document to their home institution or other. Students access their formal, official, and verifiable transcripts of record via the Ladok system, and these are digitally verifiable for 90 days.

Practical Information

Student accommodation	Mid Sweden University cooperates with local housing companies for student accommodation. Please note that to qualify for student housing guarantee, students are required to study fulltime and be admitted to at least 30 credits per semester at Mid Sweden University. More information about accommodation: miun.se/accommodation Rent varies between approx. 2100-5000 SEK/month.
Break Periods	There are no official break periods, but usually a break in scheduled activity on public holidays: https://www.miun.se/en/student/newstudent/practical-guide/living-in-sweden/national-holidays
Student jobs	Exchange students and students with a study visa are allowed to work alongside their studies but it can be rather difficult to find work if they do not speak Swedish. It may also be difficult to work while studying full-time as students are expected to spend approximately 40 hours per week on their studies.
Medical insurance requirements	EU/EEA students must bring their European Health Insurance card. Students from partner universities are covered by a Swedish state insurance for foreign students in Sweden called Student IN. Please note that the scope of this insurance is limited, and it does not include home insurance. It is the responsibility of the student to make sure they have the proper insurance coverage.
