Call for the assignment of scholarships for outgoing mobility of DiSSGeA master's degree students - a.y. 2020/21

Article 1 – Selection process

The Department of Historical and Geographical Sciences and the Ancient World (DiSSGeA), following the resolution of the Department Council of 24 February 2021, announces a selection for the assignment of scholarships aimed at promoting the outgoing mobility of DiSSGeA master's degree students. The €40,000 total is to be charged to the budget of the Excellence project “Nuovi paradigmi per lo studio della mobilità nelle scienze umane”.

The scholarships will be of five types:

- A.** For carrying out activities related to the master's degree thesis -including participation in scientific conferences and congresses- to be held from 1 January 2021 to 30 November 2021. The maximum amount foreseen for each scholarship is €400, and it will be paid at the end of the activity following the submission of the original expense supporting documents.
- B.** For attending Summer and Winter Schools to be held from 1 January 2021 to 30 November 2021. The maximum amount foreseen for each scholarship is €400 and it will be paid at the end of the activity following the submission of the original expense supporting documents.
- C.** For internships and traineeships outside the University and in locations more than 100 km away from the place of residence and/or domicile to be held from 1 January 2021 to 30 November 2021. The maximum amount foreseen for each scholarship is €400, and it will be paid at the end of the activity following the submission of the original expense supporting documents.
- D.** Integration of Erasmus scholarships, only for Erasmus+ Mobility for Study 2021/22 call grantees, who accept the position. The maximum amount foreseen is €1.000 per person -for stays of 4/6 months- or €1.500 -for stays of 9/12 months-, and it will be paid at the end of the Erasmus stay following the submission of the original expense supporting documents.
- E.** Integration of Erasmus scholarships, only for Erasmus+ Study 2020/21 call candidates who were unable to request the scholarship. The maximum amount foreseen is €1.000 per person -for stays of 4/6 months- or €1.500 -for stays of 9/12 months-, and it will be paid at the end of the Erasmus stay following the submission of the original expense supporting documents.

It will be possible to submit only one scholarship request. Type B and C scholarships cannot be combined with other scholarships intended for similar initiatives provided by the University of Padua.

Article 2 - Admission requirements

The call is open to master's degree students of the University of Padua, of the courses in: Classical Humanities and Ancient History, Local Development, Sciences of Religions, Sciences for the Landscape and Historical Sciences (Curriculum Historical Sciences and Curriculum Mobility Studies), of Department of Historical and Geographical Sciences and the Ancient World (DiSSGeA)

Two application forms are attached to this call, to be used respectively for:

1. scholarship request for the realization of master's degree thesis, for participating in scientific conferences and congresses relating to the research themes of the master's degree thesis, for attending Summer and Winter Schools, for internships and traineeships (Annex A);
2. scholarship request for integration of the Erasmus scholarship (Annex B).

Article 3 – Application submission

Applications for participation (Annex A or Annex B) must be submitted **before 15 April 2021** through the Moodle platform of the School of Human, Social and Cultural Heritage Sciences, at the following address: <https://elearning.unipd.it/scienzeumane/course/view.php?id=10210#section-0>

Requested application documents:

1. application form (Annex A or Annex B), attached to this selection notice, duly filled in;
2. photocopy of a valid identity document;
3. *curriculum vitae et studiorum*, dated and signed (max. two pages);
4. self-certification relating to the exams taken in the bachelor's and master's degree (date and grade).

Requests for scholarships for the realization of master's degree thesis, for participating in scientific conferences and congresses relating to the research themes of the master's degree thesis, for attending Summer and Winter Schools, and for internships and traineeships must be accompanied by a motivational letter explaining the reasons for the request. This letter must be countersigned by a tutor belonging to the teaching staff who certifies the congruity and relevance of the activity with respect to the study plan.

Article 4 - Commission, assessment and rankings

The Commission will be appointed by decree of the DiSSGeA Director and will be composed of three professors from the Department.

The commission will form two distinct rankings: one relating to the applications submitted via Annex A (requests for thesis, conferences and congresses, Summer and Winter Schools, internships and traineeships), the other relating to the applications presented via Annex B (Erasmus scholarship integration).

For the purposes of the selection, the following requirements will be assessed:

- exam marks;
- Bachelor's degree grade;
- motivations.

The outcome of the assessment, produced at the incontestable discretion of the Commission, will be published on the Moodle platform by 30 April 2021.

Article 5 – Winners obligations

Winners must attend the planned activity and promptly provide the expense supporting documents accompanied by a short report validated by the tutor at its conclusion. Those who find themselves in situations where it is impossible to participate are required to notify the Didactic Secretariat of DiSSGeA in a timely manner and, in any case, in time to allow the scrolling of the ranking.

Article 6 – Personal data processing and privacy

In accordance to the Legislative Decree of 30 June 2003 n. 196, personal data will be processed exclusively by the University of Padua for institutional purposes and related to this announcement.
